1. 2. RETAINED RIGHTS/TERMS AND CONDITIONS

General

1. Authors/employers retain all proprietary rights in any process, procedure, or article of manufacture described in the Work.
2. Authors/employers may reproduce or authorize others to reproduce the Work, material extracted verbatim from the Work, or derivative works for the author's personal use or for company use, provided that the source and the **éclat** copyright notice are indicated, the copies are not used in any way that implies **éclat** endorsement of a product or service of any employer, and the copies themselves are not offered for sale.
3. In the case of a Work performed under a Indian Government contract or grant, the **éclat** recognizes that the Indian Government has royalty-free permission to reproduce all or portions of the Work, and to authorize others to do so, for official Indian Government purposes only, if the contract/grant so requires.

Author Responsibilities

Author/Employer Rights
